## Partnership Statutory Provisions

### 10 USC 2474

Requires the Military Department to designate depot maintenance activities as Centers of Industrial and Technical Excellence (CITEs), authorizes and encourages Public-Private Partnerships, permits performance of work related to core competencies, permits use of facilities and equipment, and permits sales proceeds to be credited to depot accounts.

### 10 USC 2563

Authorizes sale of articles and services outside DoD under specified conditions.

### FAR 45.3

Provides for contractor use and rental of government property.

### FAR 45.4

Permits provision of government-furnished material, facilities and equipment to contractors.

The Marine Depot Maintenance Command (MDMC) located in Albany, GA under the direction of Marine Corps Logistics Command (MARCORLOGCOM) operates both Production Plant Albany, GA and Production Plant Barstow, CA.

These plants maintain a highly skilled technical and engineering workforce capable of performing major overhauls and modifications to all types of military ordnance, motor transport, engineering, and general support equipment. The maintenance plants operate as multi-commodity centers that provide logistics support to Marine Forces ensuring continuous readiness and sustainment necessary to meet operational requirements.

Personnel are cross-trained to apply common skills to work on a variety of equipment in different commodities. This affords the flexibility to rapidly realign the workforce to meet the changing requirements of the Fleet Marine Force (FMF) and other customers. General areas of support include communications, electronics, engineering, optics, vehicular electronics, small arms and metrology. Plant Albany and Plant Barstow's capacity for each major commodity is highly flexible and their total capacity is relatively elastic.

Our facilities have received individual and industry-wide achievement performance awards. Awards included the Robert T. Mason Award for Depot Maintenance Excellence (2005 & 2007), Marine Corps Ground Logistics Unit of the Year, DoN Safety Excellence Award, Marine Corps Civilian Logistician of the Year, Marine Corps Enlisted Logistician of the Year, Joint Depot Maintenance Excellence Award (2007 & 2009), Theory of Constraints International Certification Organization Achievement Award, DoD Check it Campaign, Robert E. Fox Award, USMC Continuous Process Improvement, and CPI Project Excellence Award for the M16A2 Program.

## What is a Public-Private Partnership?

Public-Private Partnership is a contractual business relationship between a Marine Corps owned and operated facility and one or more private industry or other entities to perform work or utilize the Marine Corps organic support facilities and equipment.

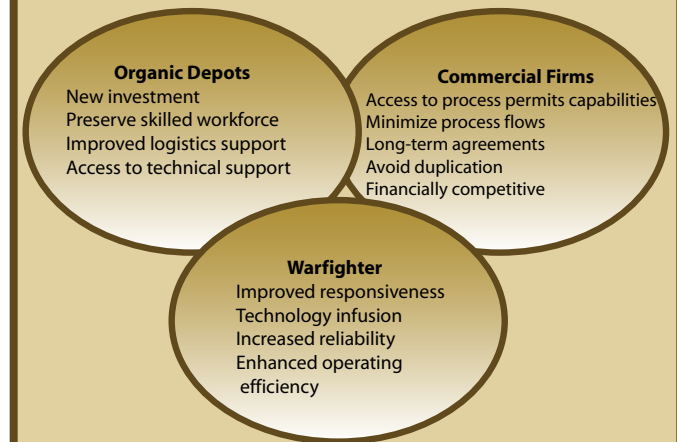
### Includes one or more of the following:

- Lease of organic equipment or facilities.
- Work-share agreements that use a combination of organic and commercial facilities and employees.
- Team arrangements in which an organic depot and a commercial firm jointly contract with a DoD third party to perform work.
- Hiring of organic depot capabilities to provide articles or services to the private sector.
