Marine Depot Maintenance Command (MDMC) Overview

Mission: “To provide maintenance and maintenance-related products and services, which meet our customers' needs in quality, schedule, and cost.”

Center for Industrial & Technical Excellence (CITE): Secretary of the Navy Memorandum, dated 19 July 2002, designated MARCORLOGCOM, MDMC as a CITE Depot Maintenance Activity.

General Information:

- MARCORLOGCOM MDMC aboard Marine Corps Logistics Base, Albany, Georgia, is comprised of two Production Plants geographically located in Albany, GA (PPA) and Barstow, CA (PPB). PPA and PPB are multi-commodity depot maintenance complexes that provide worldwide expeditionary logistics support to the FMF, other forces, and agencies. MDMC works closely with the other MARCORLOGCOM organizations in carrying out the mission of the Command, which is to provide logistics support to Marine Forces that will maintain continuous readiness and sustainment necessary to meet operational requirements.
- MDMC is capable of supporting Marine Corps ground combat and combat support equipment as well as other customers with similar needs. Personnel are cross-trained to apply common skills to work on a variety of equipment in different commodities. This affords the MDMC the flexibility to rapidly realign their work force to meet the changing requirements of the FMF and other customers.

Maintenance Production


Material Forecasting

MDMC Better Business Practices:


